# **BACKLOG INDICATOR** & CONFIDENCE INDEX

## Backlog Indicator Increases, Contractors Remain Confident

Associated Builders and Contractors (ABC) reported on February 11th that its Construction Backlog Indicator increased to 8.4-months in January. When compared to January 2024, the reading is unchanged.

The monthly increase in backlog was concentrated in the Western region, which also exhibited the largest growth in backlog over the past year. The South has the longest backlog of any region despite exhibiting the largest year-over-year decrease.

ABC's Construction Confidence Index readings for sales and profit margins improved in January, while the reading for staffing levels declined.



# **ESSENTIAL WORKPLACE TO-DOS**

## 10 To-Dos to Add to Your February Workplace List

MBEX is here to help our members stay on top of the latest changes and have an action plan for compliance when it comes to workplace laws, especially given the rapid pace at which the White House has acted in the first weeks of President Trump's second term.

Here is a quick overview of critical developments that have happened throughout January and essential items you should consider addressing in February and beyond.

#### (1.) Track Changes from Workplace Watchdogs

President Trump made several unprecedented moves in January that demonstrates a clear shift in the way the federal government will approach labor law, EEO, and anti-bias laws over the course of the next several years.

Additionally, Trump issued <u>an executive order</u> announcing the federal government will recognize only two sexes while rolling back Biden-era EEO workplace guidance on LGBTQ+ harassment.

#### (2.) Assess Your Diversity, Equity, and Inclusion Programs

The President issued a far-reaching executive order on January 21st targeting diversity, equity, and inclusion (DEI) initiative in not only the federal government, but also the private sector.

While the order created many unanswered questions and will likely face legal challenges, this explains what private employers need to know about these new federal anti-DEI initiatives and what you should do now.

#### (3.) Coordinate with Counsel on Affirmative Action Orders

Just days after the President <u>issued an executive order dismantling the race and</u> <u>gender affirmative action obligations</u> that have applied to federal contractors since the 1960s, the Labor Department announced on January 24th that it was ceasing all pending investigations and enforcement activity.

This means employers subject to pending cases, conciliation agreements, investigations, and complaints related to the now-rescinded Executive Order 11246 have now received a reprieve, but federal contractors and subcontractors will still need to continue other compliance efforts.

(4.) Create an Action Plan in Response to Sharp Immigration Policy Changes In the hours after he was sworn in, the President's administration started taking immediate action to reshape the country's immigration policies --- and <u>employers need to pay</u> <u>attention</u> given the impact these changes will soon have on the workplace.

#### (5.) Keep Up with the Evolving A.I. Landscape

The White House enacted a sweeping shift in A.I. policy in January rescinding President Biden's executive order on artificial intelligence and announcing a massive private sector-left A.I. infrastructure investment. Then, President Trump followed up with <u>an executive</u> <u>order</u> on January 23rd calling for a group of regulators to craft a new A.I. policy within six months intended to ensure "global A.I. dominance."

#### (6.) Monitor Labor Law Development

Just days into the newest Congressional session, a key Republican Senator shocked many employers by pushing for a law that would significantly tilt the playing field to the benefit of unions and labor advocates. Is this the beginning of a true labor revolution that

will upend the traditional status quo, a plan destined to go nowhere, or something in between?

Here are <u>the seven key sections of the proposal</u> and thoughts on what to expect in the coming months.

#### (7.) Get Ready for Increased OSHA Penalties

Employers are facing higher penalties for workplace safety violations in 2025 now that the U.S. Department of Labor has published its listing of annual increases. Here are <u>the key</u> <u>changes you need to know</u> and the steps you can take to ensure you provide a safe workplace for your employees.

#### (8.) Consult Your State Law Compliance Checklist

With all the news from the federal government, it's important to remember that you still have workplace obligations at the state and local levels, too. Be sure to check for compliance with any new labor laws that impact your operations.

#### (9.) Track the Latest Pay Transparency Trends

Speaking of state laws, blue states are expected to up their game this year in resistance to the Republican trifecta in the White House, Senate, and House --- and pay transparency will continue to be one of the hottest topics.

Here are <u>five tips for compliance</u> and what you need to know about pay transparency laws.

## (10.) Review SCOTUS Ruling on the Standard of Proof in Overtime Exemption Cases

The Supreme Court handed businesses a win on January 15th when it weighed in on how much evidence an employer needs to show a court to prove it correctly classified employees as exempt from minimum wage and overtime pay under the FLSA.

Here are the key points you should know about the ruling and what it means for your workplace.

#### LABAOR & WORKFORCE

□ Mishandled Electronic I-9s Could Be a Costly Immigration Threat for Employers The [Trump] administration has begun workplace raids and stakeholders predict an increase in audits of Form I-9s, the documents used to verify whether an employee is eligible to work in the U.S. In the days following Trump's inauguration, however, voices in the immigration compliance community have been increasingly sounding an alarm about a vulnerability of which many employers may be unaware: their Form I-9 vendors. (Construction Dive)

### ROBOTICS

#### \* Rosendin Electric Deploys Custom Robots to Install Solar Panels

Newly developed solar panel installation robots are drastically reducing labor costs and human toil associated with building solar photovoltaic farms, as Rosendin Electric has found after a year of successful trials on real solar jobsites. Installing panels on large solar farms is tough work, requiring multi-person crews to lug 80- to 100-lbs panels into place on preassembled mounting racks --- with some holding a panel steady while another worker screws it into place. ### MENTAL HEALTH

#### Partnership to Launch Groundbreaking Mental Health App for Construction

The first-of-its-kind mobile app provides workers immediate, confidential access to mental health services, removing barriers and eliminating the stigma often associated with seeking help. Participating construction companies will display QR codes at job sites, allowing workers to discreetly scan and connect with licensed providers for support. (Contractor Magazine)

#### A Closer Look: Komatsu's Electric Underwater Dozer

A concept machine was showcased at the recent CES show in Las Vegas, but the idea for this amphibious bulldozer is not new. While the operator remains safely on shore, data mapping and visualization technology allows the electric underwater robot to operate at depths of up to 160-feet and to see the seabed or lakebed being cleared. Trash is becoming a new treasure in building construction with advances in digitalization. Escalating prices for new building products and supply chain hurdles, coupled with the vast quantity of waste generated, have motivated the construction industry to improve its resource efficiency using digital tools. Construction and demolition waste (CDW) comprise nearly a third of all solid waste product globally. Fortunately, a large percentage of CDW is recyclable. (Architect Magazine)

## **PROJECT OF THE WEEK**

## Milwaukee Plans \$490M Public Safety Building

The Public Safety Building, at 821 West State Street in Milwaukee, holds a handful of criminal courts and holding and jury facilities for the county court system. The building is nearly 100 years old and doesn't reach state standards for courthouses, creating slowdowns in the local justice system and safety risks for those who use the facility, according to many local officials and judges.

Deferred maintenance and upkeep costs alone are more than \$300-million and don't address structural issues, data from Milwaukee County showed. A total of 10-floors containing around 60,000-square-feet of jail space have been unused since 2000, official said.

The early plan assumption is to move facilities out of the safety building, then deconstruct and reconstruct the facility. Overall, the county wants to put all the criminal courts under one roof.

The design process will take two years and the early plans aren't final.

Because the safety building is connected to the historic courthouse and the Criminal Justice Facility, the project will bring renovations to those areas as well.

In January, the country announced it selected engineering firm AECOM to provide architectural planning and design services on a multi-year project. The county also brought in a team from the National Center for State Courts' Court Consulting Services Division to seek stakeholder input.

AECOM will work on design through 2027, and construction could begin in 2028 or 2029 and continue through 2032, officials noted.


