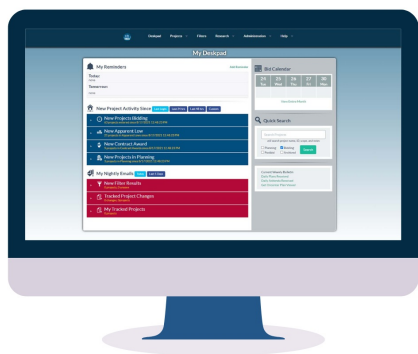

# WORKPLACE LAW UPDATE: MAY 2025

## Nine Essential Workplace To-Dos To Tackle This Month

MBEX is here to help our members stay on top of the latest changes to labor and employment law, especially given the rapid pace at which the new administration has been moving on initiatives impacting the workplace and beyond.

For the latest changes and a compliance action plan, here's a quick review of some critical developments tracked in April and a checklist of the essential items you should consider addressing throughout May.

### 1.) Check Out This First 100 Days Report For Employers

The first 100 days of any new administration sets the tone for what's to come --- and in 2025, that tone has been unmistakable: bold, fast-moving, and deeply consequential for employers. That's why employers should [check out this special report](#) --- a snapshot of where things stand, where they're headed, and what your organization should be doing to keep pace.

### 2.) Stay Tuned for More Guidance on "Disparate Impact" Claims

For decades, employers could face liability for policies and practices that didn't intentionally discriminate but had a "disparate impact" on a group of job applicants or employees based on a protected characteristic, such as race or sex. The president is now aiming "to eliminate the use of disparate impact liability in all contexts to the maximum degree possible," according to an April 23rd executive order. ### 3.) Review Rollbacks on Standards for Federally Funded EV & Clean Tech Projects

The Trump administration also rescinded a key executive order that tied federal funding for clean energy and infrastructure projects to pro-union commitments --- signaling a major shift for electric mobility companies and other federally funded employers. But lingering legal obligations remain for those already under contract. [Here's what you need to know about this labor shake-up.](#)

### 4.) Prepare for EEO-1 Reporting to Begin

This year's collection of EEO-1 reports could begin in less than a month --- and will likely not allow employers to categorize workers as "non-binary." Private employers with at least 100 employees and federal contractors with at least 50 employees should prepare to sort company data by employee job category, as well as by sex and race / ethnicity, to turn over to the EEOC by May 20 and June 24. While these dates are not yet set in stone, the compliance window will be here before you know it. [Here's what you can do to prepare.](#)

### 5.) Safeguard Your Corporate Leaders Against Rising Security Threats

Executives are increasingly at risk of becoming targets of violent acts or cyberattacks such as doxing or social engineering, and your organization must think ten steps ahead to ensure the safety of your people and the future of your business. ### 6.) Consider Alternatives to the H-1B Visa for Hiring Foreign Nationals

You may be disappointed if your candidate was not selected for an H-1B visa in the recent cap lottery --- but not all hope is lost. Whitehall Central School District* reinforces that the ability to perform essential job functions is relevant --- but not decisive --- in ADA failure-to-accommodate claims. **Nonresidential Construction Added Jobs in April**

The construction industry added 11,000 jobs in April, according to the Associated Builders and Contractors analysis of data released on May 2, 2025.

Nonresidential construction employment increased by 8,000 positions on net, with growth in 2 of the 3 subcategories. Nonresidential specialty trade added the most jobs, increasing by 4,900 positions, while nonresidential building added 3,600 jobs. Heavy and civil engineering lost 500 positions for the month.

The construction unemployment rate rose to 5.6%, while unemployment across all industries remained unchanged at 4.2% in April.

"Despite weak construction spending data for March and several economic headwinds, including high interest rates, tight lending standards and trade policy uncertainty,

backlog remains sufficiently elevated to keep industry employment growing for the time being," said ABC Chief Economic Anirban Basu.

"That said, April is likely to be the last month of economic data largely unaffected by tariffs and tariff-related uncertainty," said Basu. "The reference period for today's [May 2] report is the pay period through April 12, which may exclude staffing decisions, or project cancellations or delays, related to recent trade policy developments. While the economic outlook has worsened in recent weeks, it remains unclear how the economy will respond in the coming months."

**ECONOMIC OUTLOOK**

[U.S. Construction Spending Dips Amid Tariff Concerns](#)

The latest U.S. Census Bureau data indicates construction spending pulled back in March as economic uncertainty fosters trepidation. While showing gains, the numbers

were significantly below growth realized the year prior. In its analysis of the latest report, AGC of America noted the drop in demand coincides with growing uncertainty regarding the impacts of tariffs, particularly concerning material costs and demand for new projects. (*Finance & Commerce*)

## **TARIFFS**

### ∞ [Trade War Fallout: Contractors are Delaying Projects & Cutting Crews](#)

Plant-Tours' April 2025 survey of 500 managers and executives in manufacturing, construction and related sectors found that 59% of construction professionals cited product-cost increases as the top unexpected impact of tariffs, while 52% have delayed or canceled projects due to pricing uncertainty. Nearly half (45%) of companies reported workforce reductions of 5-10% tied to tariff pressures. (*Roofing Contractor*)

## **PROJECT MANAGEMENT**

### □ [The High Cost of Compressed Schedules](#)

Simply put, schedule compression is the desperate attempt to complete the same amount of work in a significantly reduced timeframe. It's the construction equivalent of trying to cram five pounds of sand into a ten-pound bag --- a recipe for mess, inefficiency, and ultimately, failure. While the pressure to deliver projects faster is ever-present, the path to achieving true efficiency is not in frantic acceleration, but in building a solid foundation from the outset. (*For Construction Pros*)

## **INNOVATION**

### □ [Self-Repairing Buildings? Engineers Make Living Concrete in Construction Breakthrough](#)

A team of researchers have developed a living building material composed of fungal mycelium and bacterial cells capable of self-repairing and surviving for extended periods. Unlike conventional construction materials, this bio-based composite remains viable for weeks, opening up new possibilities for regenerative architecture. The material is produced at low temperatures and relies on living cells, making it a potentially groundbreaking solution for reducing the environmental impact of the construction industry. (*Interesting Engineering*)

## **CURRENTLY IN WISCONSIN**

### □ [Ho-Chunk Casino Building Footprint Keeps Expanding](#)

Miron Construction and the Ho-Chunk Nation in April took out a building permit for the 18-story, 312-room hotel that will be the dominant landmark in the \$500-million casino / convention / hotel project off Interstate 90. Miron and Ho-Chunk estimated the construction cost of the hotel at \$185.1-million. Ho-Chunk has now taken out four building permits in 2025, for the casino and related developments --- the casino, the foundation for the hotel, the foundation for the parking garage, and now the hotel itself. All together, the permits estimate the construction cost at \$293.7-million. There is one major component that Miron still has to apply for a permit --- the convention center. (*Beloit Daily News*)

## Excelsior Apartment Pitch Would Include Dock Cinema Revamp

About a year ago, Mithun Cos. was pitching a hotel property on a currently vacant lot that overlooks Lake Minnetonka's Excelsior Bay.

After receiving mixed feedback from the city, the Wayzata-based development company is back with another proposal. This time, it's looking to build a mixed-use, 43-unit apartment building that will also incorporate a "reimagining" of the Dock Cinema next door, planning documents show.

The apartment building would be three stories, with the bottom floor designated for retail. The retail floor would have about 5,600-square-feet of commercial space.

The building is proposed at 10 Water Street, and the proposed unit spread includes 13 one-bedrooms, 9 one-bedrooms with a den, 12 two-bedrooms, 6 two-bedrooms with a den, and 1 three-bedroom apartment.

The Dock Cinema would be designed as a potential community space with plans to restore the upper-level theater. Mithun Cos. plans to team up with a local nonprofit to operate the theater, which will allow for screenings of local films, special Q&As with filmmakers and allow space for community events.

The Dock Cinema was previously known as the Tonka Theater, and according to documents, would be renovated to bring back its original marquee.

The restoration of the historically designated Dock Cinema comes with an asterisk. A back section of the theater would need to be demolished. Neither a demolition nor partial demolition of a contributing building in the historic district has ever been approved.

The Excelsior Heritage Preservation Commission did not act for or against recommending approval but rather moved to ask the city staff to draw up a resolution that was reflective of the discussion had by the commissioners. The resolution will be reviewed by the commission at its next meeting on May 27th to be sent to the city council.
